I. GENERAL TERMS AND CONDITIONS

- a) This Tender is invited for the **Supply, installation, testing, commissioning and maintenance of CCTV Surveillance Security System at Family Health Centers at Kayyur, kasargod District and Amarambalam Malappuram District** one of the projects undertaken by C-DIT.
- b) C-DIT reserves the right to cancel any or all tenders without assigning any reason whatsoever.
- c) The intending tenderer can visit the office location during office hours before submitting the tender.

II. ELIGIBILITY CRITERIA OF BIDDER

- a) Bidder should be a registered company or registered business firm as per Indian Law, doing similar business.
- b) The bidder should have a registered office in Kerala (Documentary Evidence should be attached) and a well-equipped authorized service Centre (Preferably at Thiruvananthapuram/Kollam).
- c) Bidders should have valid GST registration.
- d) Bidders should have PAN allotted to him by IT Department.

- e) Bidder shall not be blacklisted by any of the department/organizations of the Govt. of India/State Govt/PSUs.
- f) To qualify for award of the work, the intending tenderer must have an experience in successfully completed at least three orders of similar nature having contract value not less than 1 lakh each during last 2 years.
(Documents should be attached)

III. SCOPE OF WORK

To identify integrators/contractors to undertake work for “Supply, installation, testing, commissioning and maintenance of CCTV Surveillance Security System **at Family Health Centre at Kayyur, kasargod District and Amarambalam Malappuram District.**

IV. SPECIAL CONDITIONS FOR THIS WORK

1. It is mandatory for the bidder to deploy qualified professionals to install, commission & maintain the equipment, as defined under scope of work.
2. The successful bidder shall provide a warranty of 3 years for all active/passive items supplied. The warranty shall cover manufacturing defects, performance issues, and replacement of faulty components at no additional cost.
3. The bidder shall also provide a warranty of workmanship for all CCTV installation and commissioning work for a period of 3 years.
4. During the warranty period, the bidder shall ensure timely maintenance and support services, including preventive and corrective maintenance. If any item or service is found defective during the warranty period, the bidder shall repair or replace it without any additional charges.
5. The successful bidder shall install CCTV surveillance systems as per the specifications prescribed in the tender document and should install the cameras in the CHC building.
6. **The Agency shall ensure warranty of the equipment supplied and the materials should have a minimum OEM warranty of three years.**
7. The offered CCTV cameras must be: **STQC approved by Standardization Testing and Quality Certification (MeitY, Govt. of India)** and **approved** by

Govt. of India.

8. Technical and other details of the items offered along with make & model and complete specification should also be mentioned in the tender.
9. The tenders shall invariably be accompanied by manufacturers catalogues and leaflets giving full technical specifications.
10. Bidder should not quote discontinued Brands or Models or for which OEM support is not available.
11. The successful bidder shall supply all equipment/ materials required to execute the work in the respective site as per the Bill of Material quoted.
12. All the Cameras have to be cabled by UTP CAT-6 Cable in the Buildings and connected to PoE Switch using structured cabling for the LAN. Proper conduit as per the specification should be provided.
13. The bidder shall set up a Monitoring facility at the Family Health Centres , Kayyur, Kasargod and Amarambalam, Malappuram. The bidder shall do all electrical and network works for setting up of the CCTV solution.
14. The bidder is responsible to perform the highest quality of workmanship, including ensuring aesthetics while executing this project. The bidder should ensure that the cables and equipment are placed with proper routing of cables keeping the aesthetics of the site environment intact.
15. The Camera Video feeds have to be transmitted 24X7 and able to view in the Monitor provided by the bidder and also (through Mobile/ Tab if required).
16. The CCTV system installation includes the installation of indoor and outdoor cameras for proper surveillance coverage at each location.
17. The technical specifications mentioned in this document are the minimum suggestive specifications. The vendor not meeting these minimum suggestive technical specifications are liable to be rejected.
18. Bidder should survey and evaluate the site conditions, if necessary, before submitting offers and are responsible to supply and install the surveillance system including all necessary cabling, conduits, wiring and other related accessories.
19. The bidder shall ensure three years comprehensive warranty as per this

document to all equipment, parts supplied including all works associated with the project from the date of successful User Acceptance Test.

20. Successful bidder should provide training to the team identified by the user for operation of the CCTV System and handhold on job.

The bidder shall handover all software products license keys/ passwords/ softwares/ installation files including user manual and all necessary documentation to C-DIT.

V. SPECIFICATIONS & REQUIREMENTS

BOM is attached as **ANNEXURE-I**, Technical Specification Attached as **ANNEXURE-II** and, EMD Exemption Certificate **ANNEXURE-III**.

VI. OTHER TERMS AND CONDITIONS

1. The bidders will be responsible for effecting supply and installation to the entire satisfaction of the undersigned or his authorized representatives.
2. The undersigned does not bind himself to accept the lowest tender and reserve himself the rights of accepting the whole or any part of the tender and the bidder shall be bound to supply the accepted item at the rates quoted.
3. **Three offices combined requirement is detailed in the Commercial bid Form-A. Bidder must quote all the items in the Commercial bid and execute the work as per the requirements in the respective locations (Family Health Centers) attached in Annexure-1.**
4. **BOQ should be submitted in your Letter Head.**
5. **Bidder shall submit Compliance sheet attached along with this tender.**
6. No advance payment will be made against supplies.
7. **The rate quoted by the bidder shall be inclusive of all charges.** Rates quoted by the bidder shall be valid for a period of six months from the date of opening of the tender.

8. **The rate should be quoted for the unit shown in the list including GST and tenders which do not indicate this essential information will not be considered.**
9. **The bidders shall submit the rate in “FORM A” in a sealed envelope.**
10. The rate quoted for the materials/services shall be firm and no enhancement will be allowed under any circumstances.
11. C-DIT reserve the right to cancel any or all tenders without assigning any reasons whatsoever.
12. **Performance Bank Guarantee (PBG)/Security Deposit:** The Bidder, in the event of an order, should furnish a bank Guarantee from an Indian Nationalized Bank at no extra cost in a Performa prescribed by C-DIT for an amount equivalent to 5% (Five percent) of the value of the contract. The PBG shall be valid for period of 24 months from the date of commissioning of the work.
13. **EMD:** The bidder shall submit EMD of Rs. 5,000/- (Rupees five thousand only) along with the tender
14. **PAYMENT TERMS:** 100% payment against successful Supply, installation & commissioning of the Equipment against submission of invoice and Performance Bank Guarantee.
15. **AFTER SALES SERVICE**
 - Service support personnel should be available at any time on demand. The bidder has to rectify the fault within 24 hours of service calls.
 - The Telephone Number and address of the designated persons should be submitted for reporting faults during the warranty period
16. **Agreement:** The Successful bidder has to enter an agreement with C-DIT in Rs.200 worth non judicial stamp paper immediately on getting confirmed work order.

17. **Authority:** The authority for the acceptance of the tenders rests exclusively with the C-DIT. The C-DIT does not undertake to accept the lowest or any particular tender or to assign any reason whatsoever for the rejection of any tender.
18. At any time prior to the deadline for submission of tenders, the C-DIT may, for any reason deemed fit by it, modify/amend the tender documents by issuing suitable amendment(s)/ corrigendum's to it.
