FOR BINDING OF CONSERVED VOLUMES

I. GENERAL TERMS AND CONDITIONS

1. This Tender is invited for the "**For the rebinding of conserved volumes**" as per the tender specification.
2. C-DIT reserves the right to cancel any or all of the tenders without assigning any reason whatsoever.

II. ELIGIBILITY CRITERIA

1. Only those firms or individuals which in their individual capacity, satisfy the following criteria, need to quote for this tender.
2. The bidders will be responsible for executing the work as per the entire satisfaction of the undersigned or his authorized representatives. In case any defect in the work executed item supplied is noticed, such item will be rejected at the risk and cost of the contractor.
3. Bidder shall not be blacklisted by any government agencies. Police verification certificates shall be provided if required
4. Bidder should be an Indian company/firm/Individual having experience and capacity to undertake performs similar works of value.

5. To qualify for award of the work, the intending bidder must have in its name as a supplier/prime contractor/individual with experience of having successfully executed similar natures of work. **(Certificates/Documentary Evidence should be attached)**

II.SPECIAL CONDITION FOR THIS WORK

1. Bidder shall provide skilled manpower at the office of CDIT at Thiruvananthapuram as per the requirement who are experienced in binding the special type (the brittle paper without damaging them).
2. The work shall be executed in CDIT premises as per the instruction of CDIT official.
3. Selection of the personals shall be strictly based on the practical experience which will conduct in CDIT premises.
4. The bidders shall quote the stitching and binding charges separately for books with 252 sheets and 62 sheets in the format attached as Annexure I
5. The number of sheets and volumes may vary slightly depending on the physical condition of the records.
6. Bidders may inspect the item (old brittle paper documents) during office hours, from 10:00 A.M. to 5:00 P.M on working days of CDIT in presence of the concerned official.

IV. Other Terms and Conditions:

1. The undersigned does not bind himself to accept the lowest bid offer and reserves himself the rights of accepting the whole or any part of the bid offer and the bidder shall be bound to provide the services at the rates quoted.
2. Bidder shall bring necessary tools for the binding purpose.
3. No advance payment will be made.
4. **The rate quoted by the bidder shall be inclusive of all (applicable taxes, transportation charges and delivery charges at site, etc. shall be stated invariably)**
5. Rates quoted by the bidder shall be valid for a period of six months from the date of opening of the tender.
6. The rate should be quoted in the Annexure -I for the unit shown in the list and bid offers which do not indicate this essential information will not be considered.
7. The rate quoted for material shall be firm and no enhancement will be allowed under any circumstances during the period of the six month contract. The contract may be extended for another period as per mutual approval
8. If the bidder furnishes wrong and/or misleading data, statement(s) etc. about technical acceptability of the goods and services offered by it, its tender is liable to be ignored/ rejected in addition to other remedies available to the purchaser in this regard.
9. Any dispute / difference between the parties arising out of and in connection with the contract shall be settled amicably by mutual negotiations.
