2. The bidder should have a registered office in Kerala (Documentary Evidence should be attached) and a well-equipped authorised service centre (Preferably at Thiruvananthapuram/Ernakulam/Kozhikode).
3. Bidder must have a currently valid PAN and GST registration.
4. An undertaking to the effect that the bidder has not been blacklisted by any of the department/organizations/PSUs/institutions of the Govt. of India/State Govt

5. **The programme will be completed by 8.00 pm on 26th April 2025.**
6. The undersigned does not bind himself to accept the lowest tender and reserve himself the rights of accepting the whole or a part of the tender and the bidder shall be bound to supply the accepted item at the rates quoted.
7. **In case, the supplied Laptop is not functioning properly/ defective, the bidder shall be responsible to replace the same with a new one immediately.**
8. **The technical specifications mentioned in this document are the minimum suggestive specifications. The vendors who did not meet these minimum suggestive technical specifications are liable to be rejected.**
9. No advance payment will be made against supplies.
10. **The rate quoted by the bidder shall be inclusive of all charges.** Rates quoted by the bidder shall be valid for a period of one month from the date of opening of the tender.
11. **The Bidder with GST registration should quote rate for the unit shown in the list including GST and tenders which do not indicate this essential information will not be considered.**
