I. GENERAL TERMS AND CONDITIONS

1. This Tender is invited for the "***Tender for the supply of Nepalese Tissue Paper***" for the conservation purpose as per the tender specification.
2. C-DIT reserves the right to cancel any or all of the tenders without assigning any reason whatsoever

II. ELIGIBILITY CRITERIA

Only those firms which in their individual capacity, satisfy the following criteria, need to quote for this tender.

- a) The Bidder should be a registered company or registered business firm as per Indian Law, doing similar business. **(Documentary evidence should be attached)**
- b) The firm shall have experience in similar nature of work with Supply of Similar Items during the last three financial Years as on MARCH 2025 with a minimum order value of not less than Rs.1 lakhs. **Copy of relevant document shall be submitted along with the tender documents.**
- c) Bidders should have valid GST registration. **(Attach Documentary evidence).**

- d) Bidders should have PAN allotted to him by the IT Department. **(Attach Documentary evidence).**
- e) The agencies should not have been blacklisted by Govt. agencies/ Autonomous Bodies/ public sector undertakings by any Central or State government. A self-declaration of the agency showing that they are not blacklisted in India/abroad shall be uploaded **(In company letterhead)**

II. Other Terms and Conditions:

1. The undersigned does not bind himself to accept the lowest bid offer and reserves himself the rights of accepting the whole or any part of the tender and the bidder shall be bound to supply the accepted items at the rates quoted.
2. No advance payment will be made against supplies.
3. **The rate quoted by the bidder shall be inclusive of all (applicable taxes, transportation charges and delivery charges at site,** etc. shall be stated invariably).
4. The bidders will be responsible for effecting providing to the entire satisfaction of the undersigned or his authorized representatives. In case any defect in the item provided is noticed, such item will be rejected at the risk and cost of the supplier.
5. **The bidder shall submit the price offers in “Form A” in a sealed envelope.** The rate quoted for supply/work shall be firm and no enhancement will be allowed under any circumstances. Rates quoted by the tenderer shall be valid for a period of Six months from the date of opening of the tender.
6. Rates quoted by the bidder shall be valid for a period of six months from the date of opening of the tender.
7. Delivery period shall be specifically indicated in the supply order and shall be strictly adhered to. In general the supply shall be arranged within **10 days** on receipt of the confirmed supply order. Any delay in the delivery after placing the supply order may result in cancellation of the supply order or payment of

liquidated damages @ ½% per day of the value of the supply order subject to a maximum of 10% of the price of the supply order.

8. The rate should be quoted for the unit shown in the list and bid offers which do not indicate this essential information will not be considered.
9. The rate quoted for material shall be firm and no enhancement will be allowed under any circumstances during the period of the contract.
10. If the bidder furnishes wrong and/or misleading data, statement(s) etc. About technical acceptability of the goods and services offered by it, its tender is liable to be ignored/ rejected in addition to other remedies available to the purchaser in this regard.
11. Items offered shall conform in all respects to the relevant Indian Standard Specifications.
12. Any dispute / difference between the parties arising out of and in connection with the contract shall be settled amicably by mutual negotiations.
13. C-DIT reserve the right to cancel any or all the tenders without assigning any reasons whatsoever.

14. PAYMENT TERMS

100% payment after successful supply against the submission of invoice and submission of performance bank guarantee.

15. **Authority:** The authority for the acceptance of the tenders rests exclusively with the C-DIT. C- DIT does not undertake to accept the lowest or any particular tender or to assign any reason whatsoever for the rejection of any tender.

equivalent to 5% (Five percent) of the value of the contract. The PBG shall be valid for period of 6 months from the date of executing the contract agreement.

19. **Agreement:** The Successful bidder within 7 days of getting confirmed work order has to enter an agreement with C-DIT in Rs.200 worth non judicial stamp paper, to ensure work standards and quality of materials used.
