I) GENERAL TERMS AND CONDITIONS

2. C-DIT reserves the right to cancel any or all tenders at any time if so required, without assigning any reason whatsoever

II) ELIGIBILITY CRITERIA OF BIDDER

1. Bidder should be a registered company or registered business firm as per Indian Law, doing similar business.
2. Bidder must have a currently valid PAN and GST registration.
3. An undertaking to the effect that the bidder has not been blacklisted by any of the department/organizations/PSUs/institutions of the Govt. of India/State Govt

III) REQUIREMENT SPECIFICATIONS

3. The undersigned does not bind himself to accept the lowest tender and reserve himself the rights of accepting the whole or a part of the tender and the bidder shall be bound to supply the accepted item at the rates quoted.
4. **The technical specifications mentioned in this document are the minimum suggestive specifications. The vendor not meeting these minimum suggestive technical specifications are liable to be rejected.**
5. No advance payment will be made against supplies.

6. **The rate quoted by the bidder shall be inclusive of all charges.** Rates quoted by the bidder shall be valid for a period of one month from the date of opening of the tender.
7. **The Bidder with GST registration should quote rate for the unit shown in the list including GST and tenders which do not indicate this essential information will not be considered.**
8. The bidder shall quote the rates for the supply of **Headset** in "FORM A". The tenders which do not indicate price information for all the listed items in the tender will not be considered.
9. **The bidders shall submit the rate in "FORM A" in a sealed envelope.**
10. Delivery period shall be specifically indicated in the supply order and shall be strictly adhered to. In general the supply shall be arranged within **7 days** on receipt of the confirmed supply order. Any delay in the delivery after placing the supply order may result in cancellation of the supply order or payment of liquidated damages @ $\frac{1}{2}\%$ per day of the value of the supply order subject to a maximum of 10% of the price of the supply order.
11. The rate quoted for the materials/Services shall be firm and no enhancement will be allowed under any circumstances.
12. C-DIT reserve the right to cancel any or all tenders without assigning any reasons whatsoever.
13. **Agreement:** The successful bidder has to enter an agreement with C-DIT in Rs. 200 worth non judicial stamp paper immediately on getting confirmed work order.
14. **Warranty:** The product should have minimum one year warranty.
15. **Authority:** The authority for the acceptance of the tender rests exclusively with the C-DIT. C-DIT does not undertake to accept the lowest or a particular tender or to assign any reason whatsoever for the rejection of any tender.
