TENDER TERMS FOR PROVIDING VEHICLE SERVICES

GENERAL TERMS AND CONDITIONS

- a) This Tender is invited for providing vehicles services for the conduct of **Vision 2031 International Conference on Development and Democracy** to be held at different venues in Thiruvananthapuram city from 15th to 17th February 2026 , one of the projects undertaken by C-DIT
- a) C-DIT reserves the right to cancel any or all tenders without assigning any reason whatsoever

ELIGIBILITY CRITERIA OF BIDDER

- a) Bidders should be an Indian company/ firm engaged in providing similar services for events/ exhibitions having its own capacity to cater the requirements at Thiruvananthapuram, Kerala from 15th to 17th February 2026 .
- b) Bidders should be an Indian company/ firm based and established in India.
- c) Bidders should have valid GST registration.
- d) Bidders should have PAN allotted to him by IT Department.
- e) Bidder shall not be black listed by any of the department/organizations of the Govt.of India/State Govt/PSUs.
- f) The bidder must have a software or app to manage vehicle scheduling for the seamless coordination and vehicle tracking (Self declaration to be attached and the software /app must be demonstrated as a pre requisite for eligibility qualification immediately on opening of tender).
- g) Vehicles should have valid documents provided by RTO (ie registration, Insurance, permit, Fitness)

OTHER TERMS AND CONDITIONS

1. The bidders will be responsible for effecting supply to the entire satisfaction of the undersigned or his authorized representatives.
2. C-DIT reserves the right to split the items/services among one or more bidders, at the sole discretion.
3. The undersigned does not bind himself to accept the lowest tender and reserve himself the rights of accepting the whole or any part of the tender and the bidder shall be bound to supply the accepted item as per the rates quoted.
4. **The rate quoted by the bidder shall be inclusive of all charges.** Rates quoted by the bidder shall be valid for a period of six months from the date of opening of the tender.
5. CDIT is not bound to assign any reason for rejecting any or all the tenders. It also reserves the right to accept/reject (part/whole) or any other tender(s) at their sole discretion without assigning any reason thereof. Its decision in the matter shall be final and binding
6. **Bidder can quote either one or both type of vehicles. Evaluation will be based on lowest bidder who quoted each type of vehicle.**

7. **CDIT has the sole discretion to split the order or combine the work.**
8. **The bidder shall submit an amount of ₹1000/-** as Tender fee in the form of a Demand draft (from any Nationalized/scheduled bank) drawn in favor of The Registrar, C-DIT payable at Thiruvananthapuram . Intending bidders can also remit the payment in CDIT accounts. Tender fee is compulsory. No exemption for MSME registered firms.
9. The following terms of payment shall be applicable for the contract
10. **The Bidder shall assign a person who shall be responsible for the Vehicle fleet Management in consultation with CDIT officials from time to time.**
11. **The bidder shall be responsible for providing the vehicle service for 3days.**
12. **The rate should be quoted for the unit shown in the list including GST and tenders which do not indicate this essential information will not be considered.**
13. The bidder shall quote the rates for providing the logistic services in“**FORMA**”. The tenders which do not indicate price information for the listed items in the tender will not be considered.
14. The payment of Toll fee /Parking fee etc if any will be paid by C-DIT as per actuals on submission of the original bill/receipts along with the final bill . This need not be included in tender rates
15. The supplied vehicles must be fully Air conditioned.
16. The bidder is responsible to present vehicle tracking software/app before C-DIT on demand, during bid evaluation.
17. **The bidders shall submit the rate in“FORM A”in a sealed envelope.**
18. The rate quoted for the providing vehicle shall be firm and no enhancement will be allowed under any circumstances.
19. C-DIT reserves the right to cancel any or all tenders without assigning any reasons whatsoever.
20. **Payment Terms:**
 - 30% of the order value will be paid as advance.
 - 70% will be released up on verification of submitted trip sheets and bills.
