SCOPE OF WORK

Scope of work primarily includes **Supply of Testing and Inspection Equipment** for security features on documents and labels for the setting up of Security Document Forensic Lab in CDIT, Thiruvallam, Thiruvananthapuram, as per the tender

specification.

I. GENERAL TERMS AND CONDITIONS

1. This Tender is invited for the " **Supply of Testing and inspection Equipment**" as per the tender specification.
2. C-DIT reserves the right to cancel any or all of the tenders without assigning any reason whatsoever

II. ELIGIBILITY CRITERIA

Only those firms which in their individual capacity, satisfy the following criteria, need to quote for this tender.

- The Bidder must be an OEM authorized dealer / reseller/supplier of the quoted items MUST have experience during the last three financial years for the supply of IT Hardware & Software. (Copies of work order for the supply of IT Hardware & Software must be supplied. Order value must not be less than 2.00 lacs in each year during the last three financial years meaning thereby total value of work orders supplied should be 6.00 lacs during the last three financial years).
- Bidder should be a registered company or registered business firm as per Indian Law, doing similar business (Documentary evidence in form of Certificate of Incorporation (Copy) issued by Registrar of Companies/Firms/ MUST be produced)
- The bidder must have a currently valid GST registration certificate and PAN.
- Bidder should submit CA certified/ Income Tax return statement having a minimum annual turnover of 10 lakhs (Ten Lakh) for the last 3 years. **Proof should be attached**
- An undertaking to the effect that the bidder has not been blacklisted by any of the department/organizations of the Govt. of India/State Govt /PSUs

III. Other Terms and Conditions:

1. The undersigned does not bind himself to accept the lowest bid offer and reserves himself the rights of accepting the whole or any part of the tender and the bidder shall be bound to providing the accepted items at the rates quoted.
2. C-DIT reserves the right to split the quantity of items to be supplied among one or more bidders, at the sole discretion.

3. The bidders will be responsible for effecting providing to the entire satisfaction of the undersigned or his authorized representatives. In case any defect in the item provided is noticed, such item will be rejected at the risk and cost of the Supplier
4. No advance payment will be made against supplies.
5. **The rate quoted by the bidder shall be inclusive of all applicable taxes.** Transportation charges and delivery charges at site, etc. shall be stated invariably.
6. **Rates quoted by the bidder shall be valid for a period of six months from the date of opening of the tender.**
7. **The bidders shall submit the rate in "FORM A" in a sealed envelope.**
8. Delivery period shall be specifically indicated in the supply order and shall be strictly adhered to. In general, the supply shall be arranged within **10 days** on receipt of the confirmed supply order. Any delay in the delivery after placing the supply order may result in cancellation of the supply order or payment of liquidated damages @ ½% per day of the value of the supply order subject to a maximum of 10% of the price of the supply order.
9. The rate should be quoted for the unit shown in the list and bid offers which do not indicate this essential information will not be considered.
10. The rate quoted for material shall be firm and no enhancement will be allowed under any circumstances during the period of the contract.
11. If the bidder furnishes wrong and/or misleading data, statement(s) etc. about technical acceptability of the goods and services offered by it, its tender is liable to be ignored/ rejected in addition to other remedies available to the purchaser in this regard.
12. Items offered shall conform in all respects to the relevant Indian Standard Specifications.
13. Any dispute / difference between the parties arising out of and in connection with the contract shall be settled amicably by mutual negotiations.
14. C-DIT reserve the right to cancel any or all the tenders without assigning any reasons whatsoever.
15. **WARRANTY**
 - The bidder shall provide onsite comprehensive OEM warranty for the Items supplied including the work executed for setting up of the system from the date of supply and installation.

- The OEM should provide onsite support, spares and other consumables throughout the warranty period, irrespective of product change or depreciation of the product.

16. **AFTER SALES SERVICE**

- Service support personnel should be available at any time on demand.
- The Telephone Number and address of the designated persons should be submitted for reporting faults during the warranty period.

17. **PAYMENT TERMS:** 80% payment would be released on successful delivery & POST operation (Power-On Self-Test) of the supplied machine as per the Purchase Order (PO). Remaining 20% of payment shall be released after completing implementation and test period of three month from the date of installation.

18. **Agreement:** The Successful bidder within 7 days of getting confirmed work order has to enter an agreement with C-DIT in Rs.200 worth non judicial stamp paper, to ensure warranty and after sales support during the warranty period

19. **Authority:** The authority for the acceptance of the tender rests exclusively with the C-DIT. The C- DIT does not undertake to accept the lowest or any particular tender or to assign any reason whatsoever for the rejection of any tender.
